## ORDER

Government of Kerala has framed the Kerala Information Technology (Electronic Delivery of Service) Rules 2010 for the overall governance of the service delivery under the e-District project. 23 revenue services have been made online throughout the state under e-District project. These 23 revenue services has been specified as 'e-services' as per Kerala Information Technology (Electronic Delivery of Service) Rules 2010. Pilot implementation of e-district project reveals that making more citizen oriented Government services as 'e-services' will enhance the transparency and efficiency of the Governance. As part of extending e-Governance in the State it has been decided in the Steering Committee meeting headed by Chief Minister held on 09-07-13 to roll out more services under e-District.

- As per letter read as 4th paper above, Director, Kerala State IT Mission has furnished a detailed proposal with regard to addition of more services under edistrict, revision of service charge payable to service under e-District, notification of utility bill payment services as e-Services and launching of e-district public portal that enables the public to avail services online by amending the Kerala Information Technology (Electronic Delivery of Service) Rules 2010.
- 4. Government after having examined the case in details are pleased to order as follows:

- (i) The following services and other Services notified by Government as 'e-services' from time to time as prescribed in Kerala Information Technology(Electronic Delivery of Service Rules)2010 will be delivered electronically to the public under e-district project
  - (1) Minority Certificate of Revenue Department.(In form No. 25-C)
  - (2) RTI Application of all departments.(In form No. 26/27)
  - (3) Public grievances application of all departments.(In form No. 28)
- (ii) The service charge for direct online application for availing services under edistrict/e-District public portal/ payment gateway services through Akshaya Centres is revised to Rs. 17(Rs. 2 Government share + Rs. 5 as value of court fee stamp + Rs. 10 as service providers' share). The share of Government and service provider will be Rs. 7 and Rs. 10 respectively.
- (iii) Affixing court fee stamp on application form 1A prescribed under e-district is done away with. The applicants will pay equal value of the court fee stamp as service charge under Government share.
- (iv) In case of RTI application, applicants are required to pay Rs.22 (Rs. 10 as share of service provider charge+ Rs. 10 as application fee under RTI + Rs. 2 as Government share) (except those categories exempted from paying application fee as per RTI Act 2005 and rules thereunder) subject to the amendment of Kerala Right to Information (Regulation of fee and cost) Rules 2006.
- (v) Persons belonging to SC/ST and BPL categories are exempted from paying Government share of service charges, provided they shall produce valid certificate to prove that they belong to eligible SC/ST/BPL categories.
- (vi)Government departments shall identify the services that can be delivered electronically and notify such services as 'e-services'. All utility bill payment services of all departments and services notified under right to Service Act shall invariably be notified as 'e-services'.
- (vii) Director, Kerala State IT Mission is authorized to launch e-District public portal so as to enable the public to avail the online services offered under e-District, by paying service charge of Rs. 10 plus payment gateway charges.

5. Necessary amendment to the Kerala Information Technology (Electronic Delivery of Service) Rules 2010 will be issued in due course. Form numbers 25-C to 28 are also appended herewith.
